Terms & Conditions

Thank you for supporting the Inaugural Helicopter Golf Ball Drop ("Event"), conducted by Memphis Athletic Ministries ("MAM" or "Sponsor"). Your registration of one or more golf ball(s) signifies your full and unconditional agreement to the following terms & conditions. In the event of any dispute, a reasonable interpretation or determination by MAM regarding the application of these terms & conditions is final and binding in all matters related to the event. **VOID WHERE PROHIBITED BY LAW AND OUTSIDE THE UNITED STATES.** Subject to all applicable federal, state, and local laws, regulations, and ordinances. Since we are limiting golf ball registrations to 1,000, all golf balls may be registered before the date of the event. The chances of winning are based on the number of golf balls registered. If fewer golf balls are registered, the chances of winning the grand prize and other prizes improve.

Eligibility

- To be eligible to register a golf ball, you must be at least 18 years old or the age of majority in your jurisdiction of residence, whichever is older as of the date of entry, and a living resident of the United States.
- The following individuals are not eligible to register golf balls:
 - Any member of the board of directors, officer, or employee of MAM, .
 - Any immediate family member residing in the same household of the board of directors or an
 officer/employee of the organization. (The TN Charitable Gaming Law defines immediate family as spouse,
 child, step-child, brother, sister, son-in-law, daughter-in-law, parent, or grandparent.)
 - Any member of the general assembly during such a member's term of office as a member of the general assembly.
 - The Secretary of State or any employee of the Secretary during the Secretary's term of office and such employee's term of employment with the Secretary.
 - Any vendors including employees, agents, or subcontractors (also includes immediate family members of
 the same household) who provide printing services, telephone services, and any records, devices, or other
 gaming related supplies and those who provide prizes for the authorized annual gaming event. Therefore,
 no employee or immediate family members in the same household of the following organizations is eligible:
 - Golf & Games Family Park
 - Kirkwood National Golf Club & Cottages
 - Flex Air Aviation
- The determinations of MAM are final and binding with respect to any matter arising out of the interpretation or application of these terms and conditions.
- A registration by an ineligible person is void and cannot be a winning golf ball. No refunds will be made to an ineligible registration, except in MAM's sole and absolute discretion.
- Winning a prize is contingent upon fulfilling all requirements set forth herein. MAM reserves the right to verify the eligibility of winners.

Registrations

- Golf balls may be registered online at <u>mamsports.org/helicopter</u> or by mail-in entry form. You must provide all required information to be eligible to register and win. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified.
- Golf balls may be registered for \$100 each. Payment for a golf ball is NOT a tax-deductible charitable contribution.
- There is no limit on the number of golf balls you may register.
- Golf ball registrants need not be present to win.
- A registration represents a chance to win the stated prizes. All registrations of golf balls are final, and no refunds will be paid.
- MAM reserves the right to reject any registration that is submitted with payment that does not constitute "good funds." A registration issued in exchange for a check returned for "insufficient funds," or for a credit card charge that was "declined," or reported as "invalid" or "stolen" is void and cannot be a winning golf ball.
- All online registrations must be received by July 16, 2021. All mail-in registrations must be received by July 10, 2021. Any registrations received after these deadlines will be ineligible. MAM assumes no responsibility for lost, late, misdirected or non-delivered mail, email, or any other failure to receive orders or deliver receipts prior to the deadlines. All defective or physically altered registrations may be disqualified.
- You will be notified of the number of your golf ball(s) on or before July 16, 2021. If you have not received notification, please contact April Eliason at april@mamsports.org or (901) 481-1006 immediately.

The Helicopter Drop

- All of the golf balls will be dropped from a helicopter at a height of at least 50'. On the ground below, there will be a target area containing thirteen numbered holes. Each hole will be the size of a single golf ball. There will be nine prizes awarded and holes #10 #13 will be alternate holes in the event that one or more of holes #1 #9 do not contain a golf ball upon inspection by a third party individual after the drop.
- The prize payouts are as follows: The golf ball in the...
 - Lowest # hole = 10% of the total amount raised
 - 2nd Lowest # hole = 5% of the total amount raised
 - 3rd Lowest # hole = 2.5% of the total amount raised
 - 4th Lowest # hole = 1.2% of the total amount raised
 - 5th Lowest # hole = 0.7% of the total amount raised
 - 6th Lowest # hole = 0.3% of the total amount raised
 - 7th Lowest # hole = 0.3% of the total amount raised
 - 8th Lowest # hole = 0.3% of the total amount raised
 - 9th Lowest # hole = 0.3% of the total amount raised
- The date of the event is subject to all laws, regulations, and acts of God that would render the event illegal, unreasonable, or impractical.

Winners

- The odds of winning a prize depend on the number of valid golf ball registrations but will not exceed 1 in 1,000. If fewer golf balls are registered, the chances of winning the grand prize and other prizes improve.
- Each prize will be awarded to only one winner. If the registration has more than one name on it, the prize will be awarded to the eligible individual whose name appears first on the registration form. That individual is solely responsible for allocating the value of the prize among the registrants.

- Each winner will be contacted by a representative of MAM by phone and email within 72 hours of the event. Before receiving prizes, winners must verify their eligibility by presenting a valid drivers license or state ID and completing IRS form w-9.
- Acceptance of a prize constitutes permission for MAM to use the winner's name, picture, video image, and relevant quotes to promote the Helicopter Golf Ball Drop.
- The winner of each prize shall have no rights to the prize itself until the winner has been verified as eligible by MAM, completed IRS form w-9, and received his or her check. Until that time, as between MAM and the winner, each prize remains the sole property of MAM.
- Verification of potential winners: ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY MAM, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE EVENT. A REGISTRANT IS NOT A WINNER OF ANY PRIZE UNLESS AND UNTIL REGISTRANT'S ELIGIBILITY HAS BEEN VERIFIED AND REGISTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

Taxes/Prize Restrictions

- Any and all applicable federal, state, and local taxes and all fees and expenses related to acceptance and use of
 prize not specifically stated herein, including but not limited to, financing charges, change of air travel fees, ground
 transportation, automobile insurance, meals, incidentals, passenger tariffs or duties, surcharges, service charges, or
 facility charges, personal charges at lodging, security fees, and/or other expenses, are the sole responsibility of
 each winner.
- The value of each prize is includible in the winner's gross income and may be subject to reporting by MAM to the Internal Revenue Service. Each winner is solely responsible for payment of all federal, state, and/or local income, sales, or use taxes due on account of his or her acceptance of the prize.
- With respect to any prize with a value of more than \$5,000, the Internal Revenue Service requires MAM to withhold federal income tax at the rate of 24%, or current rate as established by the IRS, and the winner must pay the amount of tax to be withheld to MAM as a condition of transfer of ownership of the prize.
- MAM takes no responsibility for any tax liabilities. Winners should consult a tax professional.

Release and Limitation of Liability

Each winner hereby releases and holds MAM harmless with respect to any claim based on any such occurrence. A registrant's sole and exclusive remedy for any breach of duty or conduct related to the event shall be limited to the return of the registration price paid for his or her golf ball(s). In no event shall MAM be liable to any person for any loss or injuries to earnings, profits or goodwill, or for any incidental, special, punitive or consequential, or other damages of any person or entity whether arising in contract, tort or otherwise, arising out of the event, use or ownership of the prizes.

General Conditions

If, for any reason, the event is not capable of running as planned, including infection by computer virus or bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of MAM which corrupt or affect the operation, administration, security, fairness, integrity, or proper conduct of this event, MAM may, in its sole discretion, void any suspect registrations and (a) cancel or terminate the event (or any portion thereof); (b) modify or suspend the event to address the impairment and then resume the event in a manner that best conforms to the spirit of these official rules; and/or (c) award the prize from among the eligible, non-suspect registrations received up to the time of impairment, and all eligible registrations received.
